SECRETARY OF STATE the corporation is The Mountain Home Community Chorus, Inc.

ARTICLE 2

The corporation is a nonprofit corporation.

ARTICLE 3

The purpose for which the corporation is organized:

- 1. Educational: To provide continuing education in the performance and understanding of the choral literature.
- 2. Cultural: To enhance the community by providing musical performances, both public and private. To provide the community with an outlet for any member of the community who wishes to participate in the performance of choral repertoire.
- 3. Financial: To provide means by which any funds collected may be dedicated to operating expenses without the consideration of profit, that any assets of the corporation are to become assets of the Mountain Home Parks and Recreation Dept. Thus, any donations received from "Patrons of the arts" are to be considered charitable donations to the Parks and Recreations Dept.
 - 4. Legal: To provide a means for any private, social, or govermental organization to recognize the Mountain Home Community Chorus as a business entity organized under the provisions of the corporate laws of the state of Idaho.
