**ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION**  
**OF**  
**ECKHARDT COMPANY, INC.**

Pursuant to Section 30-1-61 of the Idaho Code, the undersigned corporation hereby amends Article I of its Articles of Incorporation executed December 17, 1992, to change the name of the corporation from "Eckhardt Company, Inc." to "Engineered Structures, Inc.":

**FIRST:** The name of the corporation prior to the adoption of this amendment is Eckhardt Company, Inc.

**SECOND:** The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on MAY 25, 1993, in the manner prescribed by the Idaho Business Corporation Act:
