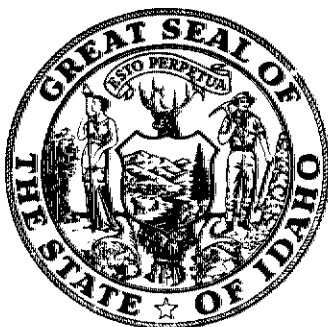

**ARTICLES OF INCORPORATION
OF
COMMITTEE FOR ACCESS TO PUBLIC LANDS, INC.**

AN IDAHO NON-PROFIT CORPORATION

ONE: The name of this corporation is Committee for Access to Public Lands, Inc., an Idaho Non-profit Corporation. The corporation is perpetual.

TWO: This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The specific purpose for which this corporation is organized is to transact an lawful activity allowed and provided for by the Idaho Non-Profit Corporation Act I.C. Section 30-3-1, *et seq.* And specifically to promote access to all public lands for all modes of transportation in the State of Idaho or elsewhere in the United States of America.

THREE: The name and address in the State of Idaho of this corporation's initial agent for service of process is Jess Beckley, 305 East Myrtle Street, Hailey, Idaho.

FOUR: (a) This corporation is organized and operated exclusively for promoting the interests of individuals in a non-profit manner within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
