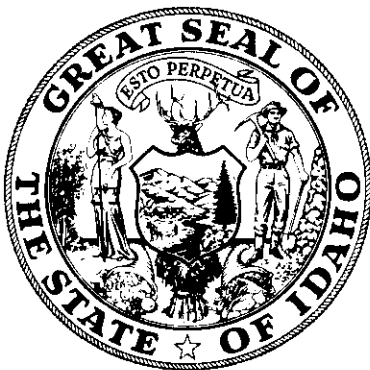

ARTICLES OF INCORPORATION  
OF

We, the undersigned, for the purpose of forming a non-profit organization, under and pursuant to Title 30, Chapter 3, Section 323, of Corporation Laws of the State of Idaho, 1979, and amendments thereof, do hereby associate ourselves as a nonprofit body corporation and do hereby adopt the following articles of incorporation.

I

The name of the corporation is: WALLACE-KELLOGG GUN CLUB, INC.

II

The period of its duration is perpetual.

III

Its purpose is to transact the business of a trap and skeet club for recreation purposes and all other business not forbidden by law.

Wallace-Kellogg Gun Club, Inc., is a nonprofit corporation.
