

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION AND COPPORATION OF STATE OF S

Pursuant to the provisions of the Idaho Business Corporation Act the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is PRECON TECHNOLOGIES, INC.

SECOND: The following amendment to the Articles of Incorporation was adopted by the stockholders of the corporation on the 24th day of April, 1990 in the manner prescribed by the Idaho Business Corporation Act:

"The name of the corporation is NSH TECHNOLOGIES, INC."
