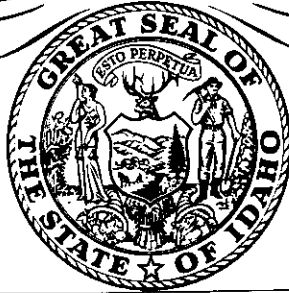

CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho do hereby certify that the original of the articles of incorporation of

YOUNG'S TIMBER YARD, INC.

was filed in the office of the Secretary of State on the **Eighth** day of **January**, A.D. One Thousand Nine Hundred **Sixty-two** and duly recorded on Film No. **114** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at

ARTICLES OF INCORPORATION

YOUNG'S TIMBER YARD, INC.

1 KNOW ALL MEN BY THESE PRESENTS:

2 That we, the undersigned, all of whom are bona fide, natural
3 born citizens of the United States of America do, under and in
4 pursuance of the general corporation laws of the State of Idaho, do
5 hereby organize, constitute and associate ourselves, and such other
6 persons as may hereafter become associated with us, into a body
7 politic and corporation, and to that end execute the following
8 ARTICLES OF INCORPORATION, and we hereby set forth and declare as
9 follows:

10 I

11 That the name of this corporation is, and shall be, YOUNG'S
12 TIMBER YARD, INC.

13 II

14 That the period of the existence of this corporation shall be
15 perpetual.

16 III

17 That the principal office of this corporation shall be located
18 at Idaho Falls, Bonneville County, Idaho, and that other offices
19 for the transaction of the business of said corporation shall be
20 established by the Board of Directors from time to time, both with-
21 in and outside of the State of Idaho, and that the meetings of the
22 Board of Directors may be had pursuant to the provisions of the
23 By-Laws either at the principal office or at such other places as
24 the By-Laws shall provide.

25 IV

26 The purposes for which this corporation is formed are as
27 follows:

28 a. To engage in a general lumber, timber, construction
29 materials, and merchandise business; to manufacture,
30 purchase, or otherwise acquire, sell or otherwise
31 dispose of logs, lumber, wood products in a processed or
32 unprocessed state, and by-products of wood or of said manu-
facturing operations, and building and construction supplies
and merchandise, either at wholesale or retail.

1 b. To purchase, or otherwise acquire, own, hold, lease,
2 sell, exchange, assign, transfer, mortgage or otherwise
3 dispose of, and to invest, trade and deal in and with
4 real property, and any and all interests therein.

5 c. To invest the capital of the company for any of the
6 purposes aforesaid, and in the building or otherwise
7 improving or adding to the marketable value of the lands
8 or other properties from time to time acquired by the com-
9 pany.

10 d. To enter into, make, perform and carry out contracts
11 of every sort and kind with any person, firm, association,
12 corporation, private, public or municipal or body politic
13 and with the Government of the United States, or any state,
14 territory or colony thereof, or any foreign government.

15 e. To lend money and to negotiate and made loans, either
16 on its own account or as agent or broker for others.

17 f. In general, but in connection with the foregoing, the
18 company may carry on any other business, whether construc-
19 tion, manufacturing, mining or otherwise, and have and
20 exercise all the powers conferred by the laws of Idaho
21 upon corporations formed under the laws of said State;
22 it being hereby expressly provided that the foregoing enu-
23 meration of specific powers shall not be held to limit or
24 restrict in any manner the general powers of the company.

25 V

26 The corporate powers, business and property of the company
27 shall be exercised, conducted and controlled by the Board of Dir-
28 ectors, who shall have the power to repeal and amend and adopt new
29 by-laws of and for the company and to hold their meetings pursuant
30 to the provisions of the by-laws, and at such places and at such
31 times as the Board of Directors may, by resolution direct, or by
32 act of the Board may fix, both within, and outside of the State of
Idaho.

VI

That the amount of the authorized capital stock of this cor-
poration shall be Twenty-five Thousand (\$25,000.00) Dollars
divided into 250 Shares of the par value of One Hundred Dollars
(\$100.00) per share.

VII

That the amount of said capital stock, i.e., 250 Shares,
shall be non-assessable.

VIII

The amount of said capital stock that has been actually subscribed is three (3) shares, and the names and residences of the persons who have subscribed therefor, and the number of shares subscribed by each, are as follows:
