



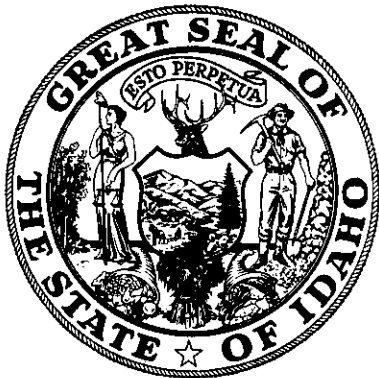
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

K & L INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is K & L INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is seventy thousand shares of common stock of the par value of one dollar each.

FIFTH: Provisions denying preemptive rights are: None

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: None.

SEVENTH: The address of the initial registered office of the corporation is 9 South Thompson Lane, Blackfoot, Idaho, 83221, and the name of its initial registered agent at such address is Kenneth Honas, 9 South Thompson Lane, Blackfoot, Idaho 83221.
