



#### "Article I


"The name of this corporation is House Calls Inc. and its duration shall be perpetual."

#### "Article III

- "(a) The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares of \$1 par value Class A voting common stock and 5,000 shares of \$1 par value Class B nonvoting common stock. Except that such Class B shares shall have no voting rights, all shares of such Class A and Class B common stock shall have equal rights and preferences, including, without limitation, rights and preferences with respect to dividends and to the assets of the corporation upon its voluntary or involuntary liquidation.
- "(b) Each share of the heretofore outstanding \$1 par value common stock is hereby changed into (i) 0.15 share of \$1 par value Class A voting common stock and (ii) 0.50 share of \$1 par value Class B nonvoting common stock."

ARTICLES OF INCORPORATION

The undersigned natural person of the age of eighteen years or more, acting as incorporator under the Oregon Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I.

The name of this corporation is House Calls Inc.

#### ARTICLE II.

The purpose for which the corporation is organized is to engage in any tawful activity for which corporations may be organized under Oregon Revised Statutes, Chapter 57.

#### ARTICLE III.

The aggregate number of shares which the corporation shall have authority to issue is five thousand (5,000) shares of common stock of the par value of one dollar (\$1.00).

#### ARTICLE IV.

The address of the initial registered office of the corporation is 900 S. W. Fifth Avenue, 25th Floor, Portland, Oregon 97204.

The name of the initial registered agent at such address is Richard A. Cantlin, Jr.

#### ARTICLE V.

The number of directors constituting the initial board of directors of the corporation is two, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
