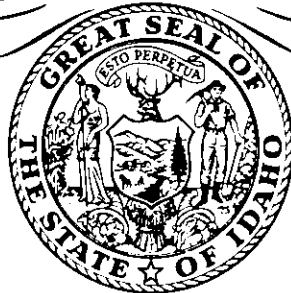

ARTICLES OF INCORPORATION  
of  
SHOSHONE COUNTY SENIOR CITIZENS COUNCIL, INC.  
a Non-Profit Corporation

We, the undersigned, being natural citizens of legal age, and being citizens and residents of the United States of America and the State of Idaho, hereby associate ourselves together to form and establish a corporation not for profit under the laws of the State of Idaho, do hereby adopt the following Articles of Incorporation pursuant to the provisions of Title 30-117(a) Idaho Code:

I.

The name of the proposed Corporation shall be:

SHOSHONE COUNTY SENIOR CITIZENS COUNCIL, INC.

II.

The purposes of said Corporation are to acquire by building and constructing or purchase, rent, lease, maintain, and occupy buildings and real property for a Senior Citizens Center; also to operate club rooms, reading rooms, meeting halls, snack bars, educational and recreational facilities; and to acquire personal properties of every kind to operate and conduct the same; to engage in any and all activities which shall permit and foster better relationship among the members and the public; to promote and foster educational, recreational, social and physical activities of its members; and to engage in such activities as shall be of moral benefit and to enhance the community welfare; to promote the betterment of the members and furnish useful information for its members for their betterment, and to do all things necessary to carry out the purposes and intents of this Corporation.

III.

This Corporation is not for profit and the objects and purposes are purely eleemosynary.

IV.

The Corporation shall be non-stock and Certificates of Membership may be issued and each member shall be entitled to a vote and all members shall have equal voting rights.

V.

That the qualifications and conditions of membership shall be fixed by the By-Laws of said Corporation, and pursuant to the Statutes of the State of Idaho as relate to non-profit membership Corporations; provided, however, that no person shall be denied membership therein by virtue of race, creed, color or religion.

VI.

The duration of this Corporation shall be perpetual.
