ARTICLES OF INCORPORATION
OF
WHISKEY MOUNTAIN OUTFITTERS, INC.

The undersigned, acting as Incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is WHISKEY MOUNTAIN OUTFITTERS, INC.

SECOND: The period of its duration is perpetual, unless dissolved by action of the stockholders or by operation of law.

THIRD: The purpose or purposes for which the corporation is organized are: trail riding, cattle drives, pack trips, guiding hunting and fishing trips and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The corporation shall have authority to issue 200 shares of stock, all of one class, \$10.00 par value.

FIFTH: Provisions denying preemptive rights are:

SIXTH: Provisions for the regulation of the
internal affairs of the corporation are: NONE.
