I, A. D. One Thousand Nine Hundred 1966, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

CHURCH OF THE MAZARINE OF COUNCIL, IDAHO, INC.

was filed in the office of the Secretary of State on the Twenty-first day of July, 1966, and duly recorded on File-Nov / microfilm of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence, from the date hereof, with its registered office in this State located at Council in the County of Adams, and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

of .

CHURCH OF THE NAZARENE OF COUNCIL, IDAHO, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all of whom are citizens of the United States of America, residents of the State of Idaho, and of legal age, have today voluntarily associated ourselves together for the purpose of forming a Non-Profit, religious corporation as provided in Title Thirty, Chapter Eleven of the Laws of the State of Idaho.

ARTICLE I

The name of this Corporation shall be: "CHURCH OF THE NAZARENE OF COUNCIL, IDAHO, INC.".

ARTICLE II

The duration of this corporation shall be perpetual.

ARTICLE III

The location and post office address of its registered office shall be Council, in Adams County, Idaho.

ARTICLE IV

This corporation has no capital stock, and there are no shares therein. Membership in this corporation shall be available to any accepted member of the congregation of the Church of the Nazarene of Council, Idaho, who is a confessed believer in the faith of said church. There shall be no dues or acceptance fees, except as may be paid by the members in the regular course of the operation of the church.

ARTICLE V

The object and purpose of the corporation shall be:

- (a) To encourage the worship of God and to provide a meeting place in Council, Idaho, for the members of the Church of the Nazarene.
- (b) To glorify God and to help in the extension of His Kingdom among men for their salvation by promoting and disseminating the Christian religion as expressed in the doctrine and practice of the General Church of the Nazarene.
- (c) To acquire, own, hold, manage, use and enjoy church property, both real and personal, and to borrow money for the benefit of religion, for

works of charity and for public worship in the manner provided by law and the By-Laws of this corporation. To provide for the election of Directors, officers and boards for the management, control, use and disposition of all property and affairs of this corporation, and to adopt By-Laws prescribing the qualifications for membership in this organization and for the election of its Directors, officers and boards and for the use and disposition of its property, and to do all such other things as might be necessary or desirable to carry out the general objects and purposes of this corporation, as well as such other things related to or incidental to such objects and purposes, and to have all other powers and authority as is now or as hereafter may be granted to like corporations under the laws of the State of Idaho.

ARTICLE VI

The government and management of the business of this corporation and the control of its property shall be vested in a Board of Five (5) Trustees, who shall be active adult members in good standing of the Church of the Nazarene of Council, Idaho, Inc., and Four (4) Stewards, the Sunday School Superintendent, the President of the Nazarene World Missionary Society and the President of the Nazarene Young Peoples Society. The pastor of said church shall act as chairman and president of said corporation and he shall be the chief or presiding officer of said board.

Each member of the Board of Trustees shall be elected to serve for a term of one (1) year, and at a special meeting called for the purpose of incorporating and electing a Board of Trustees held on Friday, the 15th day of July, 1966, at the hour of 7:00 P.M. at the Church of the Nazarene in Council, Idaho, at which meeting a majority of the members of the Council Church of the Nazarene present voted for and approved the following members to serve as the Board of Trustees for terms of one (1) year, to-wit:

PHILLIP E. CAMERON,

FREDERICK S. EDWARDS, JR.,

LYLE A. WILKINSON,

NORMAN J. VAN ORDER,

MARVIN E. NEWELL,

or until their successors are elected and can qualify. The other officers, before referred to, shall be elected annually in accordance with the By-Laws of the corporation.

At the first regular meeting of said Board of Directors, a secretary and treasurer shall be elected. These officers so elected may or may not be a member of the board as elected above, but may be any member of the church fulfilling the requirements of the board.

Notice of the time and place of the above election was published for two (2) consecutive weeks immediately prior to the holding of such election, in the "Adams County Leader", a weekly newspaper printed and published at Council, in Adams County, Idaho, and during the same period of time a copy of the Notice was posted in a conspicuous public place on the building where the said election was held and a copy of said Notice, so published and posted, together with an Affidavit of publishing and posting the same is hereto attached and made a part hereof.

ARTICLE VII

The successors to the Board of Directors shall be elected annually as follows:

Five Trustees,
Four Stewards, and the
Sunday School Superintendent,

are to be elected each year at the annual church meeting by the members of said church, which meeting shall be held within sixty days prior to the meeting of the District Assembly, public notice of the same always to be given from the pulpit at least two Sundays preceding the election.

and

President of the Nazarene World Missionary Society, and
President of the Nazarene Young Peoples Society,

are to be elected each year at the annual meeting of each subsidiary society, which meeting shall be held in accordance with the Manual and general practice of the Church of the Nazarene.

The successor in office to each of the above officers of the church shall, after election and installation into office, succeed each prior member of the Board of Directors. The election of any member by the membership of the

church or by the membership of the subsidiary societies therein represented, shall be deemed to be the election of such member as a director of the corporation and each director shall hold the title he holds in the church.

ARTICLE VIII

These Articles may be amended in conformity with Sections 30-1103 of the Idaho Code.






That a majority of those members present at the meeting voted for the following trustees of said corporation to serve for the terms of one (1) year or until their successors are elected and can qualify:
