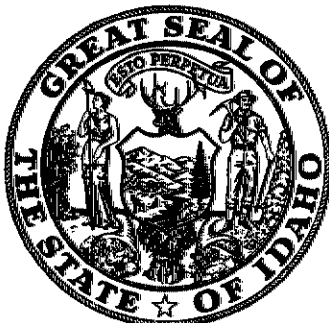

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation act, adopts the following Articles of Incorporation for such Corporation:

- FIRST: The name of the Corporation is Eastpark Partners Inc. Co.
- SECOND: The period of the Corporation's duration is perpetual.
- THIRD: The objects and purposes for which this Corporation is organized shall be the transaction of any or all lawful business for which a Corporation may be incorporated under the state of Idaho Business Corporation Act.
- FOURTH: The capital stock of this Corporation shall consist of Ten Thousand (10,000) shares of nonassessable, common stock, with no par value.


