1. LCD Properties, a Utah general partnership, has withdrawn from the partnership and transferred its limited partnership interest to Front Street Associates, a Utah limited partnership, the other limited partner of the partnership. In connection with such transfer, paragraph 4 of the original Certificate of Limited Partnership is hereby amended and restated in its entirety as follows:


"4. The names and addresses of the partners, both general and limited and the agreed value and description of the cash or property contributed to the Partnership and their percentage interests are respectively as follows:
