*Articles of Amendment to the Articles of  
Incorporation of Rainbow Recovery of Nampa,  
Inc.*

(A Non-Profit Corporation)

**Know all men by these presents, That We, the undersigned, pursuant to Article VI (6) of said Articles of Incorporation, and by unanimous vote, do hereby, make and execute the following Articles of Amendment to the Articles of Incorporation of Rainbow Recovery of Nampa Inc for the purpose of confirming tax exempt status under Internal Revenue Code 501 (c) (3). These Articles of Amendment are adopted pursuant to the authority granted in Idaho Code Section 30-146(3), and we do hereby certify:**

**That Article III (3) shall be and hereby is amended to read as follows:**

Said Corporation is organized exclusively for the charitable, religious, education and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law.) Notwithstanding any of the provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from income tax under Section 501 (c) (3) of the Internal Revenue Code.

Further: This corporation shall be empowered to operate, maintain facilities, and supervise various types of activities for persons involved in twelve step programs and those sympathetic to such.

To engage necessary employees or, volunteers to carry on programs consistent with the purposes for which this corporation is formed and empowered within State and IRS Statutes.

To engage in fund raising for the operation of said programs.

To purchase, lease and otherwise acquire, hold, operate, mortgage, convey or otherwise dispose of all kinds of property, both real and personal, both in the State of Idaho, in all other states, territories, and dependencies both foreign and domestic.

To purchase the good will, business, and all other property of any individual, firm or corporation as a going concern and to assume all it's debts, contracts and obligations providing said business is authorized by the powers herein conferred.

To own, acquire build, construct or repair buildings and to maintain buildings safely.
