# ARTICLES OF INCORPORATION

OF

# STEINER & HARROP ELEVATORS, INC.

#### KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of legal age and citizens and bona fide residents of the State of Idaho, do hereby associate together for the purpose of forming a corporation under the provisions of the laws of the State of Idaho, and do hereby adopt the following Articles of Incorporation, to-wit:

#### ARTICLE I.

The name of said corporation shall be STEINER & HARROP ELEVATORS. INC.

#### ARTICLE II.

The term of existence of said corporation shall be perpetual.

#### ARTICLE III.

The location and post office address of its registered office in this state shall be Rexburg, Madison County, Idaho.

# ARTICLE IV.

The objects and purposes for which this corporation is formed are to do any or all of the things hereinafter set forth to the same extent as natural persons might or could do, to-wit:

1. To engage in the manufacture, sale, purchase, rent and distribution of tractors, all types and kinds of farm equipment and machinery, automobiles, motor cars, motor trucks and all other mechanically propelled vehicles and all tractor, farm equipment and machinery, automobile and vehicle parts and sundries; to vend and deal in tractors, all types and kinds of farm equipment and machinery, automobiles, motor cars, motor

trucks and other mechanically propelled vehicles and tractor, farm equipment and machinery, automobile and vehicle parts and sundries and other articles; to acquire and own patents, improvements and franchises and to operate under such patents, improvements and franchises pertaining to the matters and things enumerated herein and to do all and singular the things provided by the laws of the State of Idaho under which this corporation is authorized to do business.

- 2. To construct, acquire, operate, hire, lease, mortgage, sell or otherwise dispose of elevators for elevating wheat, grain or other produce, with the requisite engines, plant, machinery and appliances therefor; and also sheds, stores, and warehouses for the reception and storage of wheat, grain, and other produce, and any other goods, wares, merchandise, and effects; and generally to carry on an elevator and storage business.
- 3. To conduct and carry on the business of buying, selling and dealing in all kinds of grain, feed, hay, fertilizer and other farm produce and farm products, live stock and provisions, coal, wood and other kinds of fuel, and all other kinds of goods, wares and merchandise; and to do a general commission, and brokerage business in any or all of the foregoing kinds of property, and also to build, acquire, own, operate and maintain a warehouse and storage business, and to do and transact all other business necessary or incidental to the conduct and carrying on of the business aforesaid.
- 4. To buy, handle, store and sell grain, flour, feed, chop, meal and all the other products that may be manufactured from grain of all kinds, and to manufacture and sell any and all the products that may be manufactured from grains of any kind; and to do a general milling and manufacturing business in said grains and other products, and in any materials necessary, useful or convenient in carrying on said milling and manufacturing business; and to carry on a general merchandising business.

5. To carry on a general hardware business, including the purchase and sale of all kinds of hardware, at wholesale and retail, and to lease, buy, hold and sell all such property, real or personal, as may be necessary to the prosecution of the said business.

6. To carry on a general mercantile or merchandise business and to purchase, sell and deal in such goods, supplies and merchandise as are or may be sold in a general store.

7. To conduct the business of a filling and service station, which business shall include the dealing in gasoline and all other petroleum products; all kinds of oils and pro-

To conduct the business of a filling and service station, which business shall include the dealing in gasoline and all other petroleum products; all kinds of oils and products used for motor fuel or lubrication; all manner of accessories and appliances to be used on motor vehicles of every description; the washing, polishing and storing of motor vehicles, and in furtherance of such business establish offices in any county, town, city, state or country, and to do any and all lawful things in and about the conduct of such business as are usual and necessary in such enterprise.
- 8. To act as agent for insurance companies in soliciting and receiving applications for all types of farm equipment and machinery, tractor, and automobile insurance, the collection of premiums, and doing such other business as may be delegated to agents by such companies, and to conduct a general insurance agency for all types of such insurance.
- 9. To purchase or otherwise acquire, own and hold unlimitedly such real and personal property of every kind and nature within and without the State of Idaho, and in any part of the world, and to convey, sell, assign, transfer, lease, mortgage, pledge, exchange or otherwise dispose of any of such property.
- 10. To purchase or otherwise acquire and to hold and own, or to sell, assign, transfer, mortgage, pledge or

otherwise dispose of stocks, bonds or other obligations of any corporation formed for, or thereafter engaged in, or purchasing any one or more of the businesses above mentioned, or owning or holding any property which the company might lawfully own or hold.

- 11. To enter into, make, perform and carry out contracts of every kind, for any lawful purpose, without limit as to amount, with any person, firm, association or corporation.
- 12. To draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, warrants and other negotiable or transferrable instruments.
- 13. To issue bonds, debentures or obligations of this corporation from time to time, for any of the objects or purposes of the corporation, and to secure the same by mortgage, pledge, deed of trust or otherwise.
- 14. To borrow money from time to time and secure the payment thereof, together with interest thereon by mortgage, deed of trust, or other lien upon or by any conveyance or transfer of any or all of its real and personal property, assets and estate, and upon its revenues, incomes and profits, or any of them.
- 15. To conduct business and exercise all or any of its powers as above specified or otherwise, in the State of Idaho, and/or in any other state, territory, and/or colony of the United States, the District of Columbia, any foreign country and/or any other part of the world as fully and to the same extent as natural persons might or could do, either alone, or in company with others, and at its option to have one or more offices and/or places of business as it desires within or without of said state, in addition to its registered and principal place of business.
- 16. All the foregoing provisions of these Articles are to be construed both as objects and powers, and it is hereby

expressly provided that the enumeration hereof of specific powers and objects shall not be held to limit or restrict in any manner the general purposes and powers of the corporation; provided, however, that nothing herein mentioned shall be deemed to authorize or permit the corporation to carry on any business or to exercise any power or to do any act which a corporation formed under the laws of Idaho, now or hereafter existing, may not, at the time lawfully carry on or do. It is the intention that the purposes, objects and powers specified in each of the paragraphs of these Articles shall, except as otherwise provided, in no wise be limited or restricted by reference to or inference from the terms of any other clause or paragraph in this Article contained or of any other provision of these Articles of Incorporation.

#### ARTICLE V.

At the annual meeting of shareholders there shall be elected from the shareholders of this corporation, a Board of Directors, consisting of such number of members, not less than three, as shall be provided by the By-Laws. The directors shall hold office for the term of one year, or until their successors are elected and qualified. That four of the incorporators named in these Articles shall constitute the Board of Directors, as follows: R. J. Steiner, T. G. Harrop, Angeline Steiner and Beatrice Harrop.

### ARTICLE VI.

The total authorized capital stock of this corporation shall be \$50,000.00, divided into five hundred shares of the par value of \$100.00 each, all of said stock shall be non-assessable common stock. All of said shares of stock of this corporation are of the same class with equal rights and voting power and without preference and/or priority of any share over any other.

# ARTICLE VIII.

Subject always to By-Laws made by the shareholders, the Board of Directors may make By-Laws, and from time to time may alter, amend or repeal any by-laws; that any By-Laws made by the Board of Directors may be altered or repealed by the shareholders at any annual meeting or at any special meeting, provided notice of such proposed alteration or repeal by the shareholders be included in the notice of such special meeting of shareholders.
