
CERTIFICATE OF INCORPORATION OF

**ARTICLES OF INCORPORATION
OF
ZIPPY SHIP "N" COPY, INC.**

I

The name of the corporation is **ZIPPY SHIP "N" COPY, INC.**

II

The period of its duration is perpetual.

III

The purpose or purposes for which the corporation is organized are:

- A: To engage in the business of photocopy and related shipping services.**
- B: To buy, sell, produce, manufacture and dispose of all kinds of goods, wares, merchandise, commodities, supplies and products, and generally to engage in any form of enterprise not contrary to law.**
- C: In addition to the foregoing purposes, the Corporation may also engage in any and all other lawful acts that, presently or in the future,, may legally be performed by a corporation organized under the laws of the State of Idaho.**

IV

The aggregate number of shares which the corporation shall have authority to issue shall be TWO THOUSAND (2000) shares, par value \$ 1.00 per share.

V

The corporation will not commence business until consideration of the value of at least \$ 1,000.00 has been received for the issuance of shares.

VI

The shareholders shall not have pre-emptive rights to acquire additional securities of the Corporation; and there shall be no cumulative voting by shareholders at any election of directors of the Corporation.

VII

The Corporation shall have a minimum of TWO (2) and a maximum of TEN (10) directors as shall be set by the Bylaws of the Corporation. Until their successors are duly elected and qualified, the original directors shall be the following:

VIII

A. The Corporation shall have the right to purchase its own shares to the extent of its unreserved and unrestricted earned surplus and capital surplus of a resolution to such effect is adopted by its Board of Directors.

B. The Board of Directors of the Corporation may designate such committee of committees as it determines in accordance with law to exercise authority as the Board of Directors shall delegate in the resolution designating such committee or committees.
