Articles of Incorporation
Harley Owners Group, Inc.,
Mountain Home, Idaho, Chapter, Inc.
March 21, 1987

Article I
The articles of incorporation are set forth.

Article II

The name of the corporation shall be: Harley Owners Group, Inc.,
Mountain Home, Idaho, Chapter, Inc.

Article III

The Harley Owners Group, Inc., Mountain Home, Idaho, Chapter, Inc.
shall be a non-profit organization.

Article IV

The period of duration will be perpetual.

Article V

The purposes of the Harley Owners Group, Inc., Mountain Home, Idaho,
Chapter, Inc. members are for promoting motorcycling activities for
Harley Owners Group, Inc., Mountain Home, Idaho, Chapter, Inc.
members by creating special chapter activities and encouraging
participation in existing events.

Article VI

The corporation shall promote membership and the corporate office is

Article XII

All Harley Owners Group, Inc. members in good standing are eligible for membership in the local chapter. An expired membership in the Harley Owners Group, Inc. organization automatically terminates that member from the local Harley Owners Group, Inc. Chapter if by decision of the chapter officers, a member's conduct at more than one event is undesirable, that person's membership in the local chapter may be suspended.

Article XIII

Chapter events may include open houses, poker runs, organized rides, field meets, or attending races. The sponsoring dealer may assist chapter officers with planning and promotion using information provided in the Harley Davidson Advertising Manual.

Article XIV

The Harley Owners Group, Inc. International Office, a division for the Harley Davidson Motor Co., Inc. is the governing body of all Harley Owners Group, Inc. activity. It will be referred to as the "Sponsor Organization." Local chapters of the Harley Owners Group, Inc. will be "non-profit" organizations assigned to provide additional services to their members and they shall be subject to all rules of the sponsor organization.
