

#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. NAME: The name of the corporation is Boyer Trucking, Inc.
- 2. <u>DURATION:</u> The period of it's duration is perpetual.
- PROFIT: This is a profit corporation.
- 4. <u>PURPOSES:</u> The purpose or purposes for which the corporation is organized is for the business of locksmith and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
