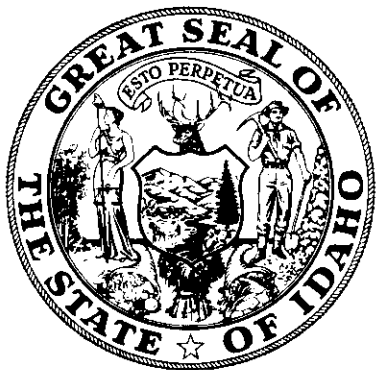

ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation is The Ada County Child Care Association, INC.

ARTICLE II

The Ada County Child Care Association shall be a nonprofit corporation.

ARTICLE III

The term for which this corporation shall exist shall be in perpetuity.

ARTICLE IV

The purposes of this corporation are as follows:

- 4.1 To enhance the image of daycare providers and clarify our purpose in our community.
- 4.2 To help improve the working conditions of daycare providers and the quality of service they offer children and parents.
- 4.3 To give daycare providers the opportunity as a group to influence licensing standards and requirements.
- 4.4 To define quality daycare and work for changes we feel necessary on a county, city, and state level.
- 4.5 To promote camaraderie among daycare providers.
- 4.6 To provide an exchange of ideas among all persons in family daycare.
- 4.7 To do each and everything necessary, suitable, or proper for the accomplishment of any of the purposes.
