

Block fi. Pay special attention to the mailing address. If the correct mailing address is not given in Block 1, strike it out and write in the correct address. Note: To ensure furture mailings, the corrected address must be inside Block 1.

Block 2: To change the registered agent or office, strike the incorrect information and write in the correct information. Note: The office of the registered again must be at a street address in idento; not a Post Office Box or Personal Mail Box.

Black 3: Only a new registered agent must sign in Block 2.

Block 4: Enter names and business addresses of president, secretary, and directors (for corporations only) or menagera/members (for LLC's only). Note: Putting "earns as test yeer" or "same as above" will not be accepted.

Block 6: May not be altered through the use of this form.

Block 8: The annual report must be signed by a person authorized to represent the corporation/LLC. Print or type the name and title of the signer below the signature.
