**ARTICLES OF AMENDMENT

Pursuant to §§30-1-1001 et seq. of the Idaho Code, the following Articles of Amendment are hereby adopted by the above corporation:

- (a) The name of the corporation is H&H Cleaning Services, Inc.
- (b) The text of the amendment adopted is as follows: "The name of the corporation shall be H&H Consulting Services, Inc."
- (c) The date of the adoption of the amendments by the shareholders was May 1, 1997.
- (d) The number of shares outstanding is One Thousand (1,000). The number of shares entitled to vote thereon is One Thousand (1,000). There is only one class of stock.
