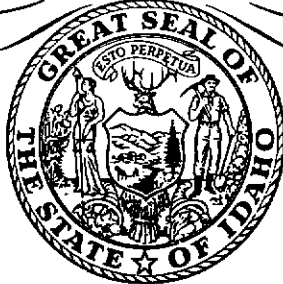

ARTICLES OF INCORPORATION

TAURCAN ENTERPRISES, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of the State of Idaho, do hereby certify as follows:

ARTICLE I

The name of the corporation shall be TAURCAN ENTERPRISES, INC.

ARTICLE II

The objects and purposes for which this corporation is formed and the powers of such corporation are as follows:

1. To purchase or in any wise acquire for investment or for sale or otherwise, personal property of every kind, including tools and equipment, real property, land, contracts for the purchase or sale of real property, buildings, improvements, and any other property of any kind or tenure or interest therein, and railroad depots, tracks, ways, and other terminal properties or facilities, and any property works or undertakings connected with the use or development of any property of the company within the State of Idaho, and within any other State or Territory of the United States; and as the consideration for same to pay cash or to issue capital stock, debenture bonds, mortgage bonds, or other obligations of the company; and to sell, convey, lease, mortgage, turn to account or otherwise deal with all or any part of the property of the company.

2. To manage, improve, develop, and turn to account any land or contracts for purchase or sale of lands or personal property of every kind, including but not limited to tools and equipment acquired by the corporation, or in which the corporation is interested, and in particular laying out sites, establishing towns, and improving the same by laying out and preparing the same for building purposes, constructing, altering, and improving buildings thereon, and by planting, paving draining, irrigating, cultivating, letting on building lease or building agreement, and by advancing money to, making subscriptions for, and entering into contracts and arrangements of all kinds with builders, tenants, and others.

3. To buy, sell, distribute, import, export, manufacture, service, and otherwise deal in all products of any kind or nature.

4. To purchase improve, develop, lease, exchange, sell, dispose of, and otherwise deal in and turn to account, real estate; to purchase lease, build, construct, erect, occupy and manage buildings of every kind and character whatsoever; to finance the purchase, improvement, development, and construction of land and buildings belonging to or to be acquired by this corporation, or any other person, firm, or corporation.

5. To process, deal in, manufacture, install, store, handle, transport, or otherwise work in or with materials of all kinds.

6. To act as general contractor for the construction, repairing, remodelling of buildings or public works of all kinds, and for the improvement of real estate, and the doing of any other kind of business and contracting incidental thereto or connected therewith, and doing and performing any and all acts or things necessary, proper, or convenient for or incidental to the furtherance or the carrying out of the powers or purposes herein mentioned.

7. To acquire, buy, sell, trade, bargain and otherwise deal in and with all types and kinds of realty and all interestes therein., including but not limited to mortgages, trust deeds, securities, equities and interest.

8. To loan money on realty, personalty or interests therein and otherwise deal in any manner whatsoever in tangible or intangible property, both real and person, and to own and hold real and personal property of every kind and nature, to rent or lease the same.

9. To conduct any business, retail or wholesale, of any kind or nature within the State of Idaho, and within any other State or Territory of the United States, and to do any and all things necessary, reasonable, proper, convenient or incident to carrying out the purposes for which this corporation is formed.

10. To borrow money and to pledge, mortgage or hypothecate corporate property, or in any way or manner secure the payment of the same.

11. To acquire the operating name, good will, property rights, and the whole or any part of any estate, tangible or intangible, and of any business, and to assume the liabilities of any person, firm, association, corporation or other business organization and pay for same, and to hold in any manner or dispose of all or any part of the property so acquired

12. To conduct in any lawful manner the whole or any part of any business of the corporation, and to preserve or protect the assets of this corporation, and to exercise all powers necessary or expedient to do so.

13. To do all things which a natural person might do, it being expressly provided that the aforesaid enumeration of purposes shall not be construed as limitations upon the powers and purposes of this corporation.

ARTICLE III

This corporation shall have perpetual existence.

ARTICLE IV

The location and post office address of the registered office of this corporation is Boise, Idaho.

ARTICLE V

The capitol stock of this corporation shall be the sum of TEN THOUSAND DOLLARS (\$10,000.00) divided into 10,000 shares of common stock, each share having a par value of ONE DOLLAR (\$1.00) per share. No distinction shall exist between the shares of this corporation and all such shares shall have the same rights in such corporation, and shall be non-assessable when paid in full.
