We hereby certify:

(Organization Meeting.) That a meeting of the worshipers and members of the Church and congregation known as the MIDDLETON BIRE MISSION, INC. was duly and regularly held on Tuesday, December 29th., 1964 at eight o' clock P.M. in the church building of said church, situated on Corner of 2nd. and Hawthrone Streets, in Middleton, Canyon County, State of Idaho, which said church building is the place where said members and congregation statedly meet for public worship; that said meeting was held for the purpose of authorizing the incorporation of said church and for electing three trustees to take charge of the property and estate, both real and personal of said church and congregation, and to transact all affairs relative to said church and its property, which said trustees shall become a body corporate, agreeable to and in conformity with the statute in such case made and provided.

(Notice of Meeting.) That due and regular notice, in writing, of the holding of said meeting at the time and place as aforesaid; for authorizing the incorporation and for election of trustees as aforesaid, was given by publication for two successive weeks in the Boise Valley Herald, a paper published in the city and county where such church is located and said meeting held; and also by giving notice from the pulpit and by posting notice in a conspicuous place on the building where such election was held for the same length of time.
