The undersigned, acting as the incorporator of a corporation (hereinafter referred to as "CorporationA")Ounder the Idaho Business Corporation Act (the "Act"), adopts the following Articles of Incorporation for the Corporation.

Article 1. Name

The name of the Corporation is Eric's Auto Sales, Inc.

Article II. Period of Duration

The period of duration of the corporation is perpetual.

Article III. Purposes and Powers

Section 1. Section 1. Number. The aggregate number of shares of common stock which the

Section 2. Dividends. The holders of the common stock shall be entitled to receive, when and as declared by the Board of Directors, as pernitted by the Act, dividends or distributions payable either in cash, in property, or in shares of the capital stock of the Corporation.

Section 3. Stock Non assessable. The private property of the shareholders of the Corporation shall not be subject to the payment of corporate debts to any extent whatsoever, and shares of the Corporation shall not be subject to assessment for the purpose of paying expenses, conducting business, or paying debts of the Corporation.

Section 4. Voting Power. The entire voting power for the election of the Directors and for all other purposes shall be vested exclusivelyin the holders of the common stock, who shall be entitled to one vote for each share of common stock held by them record.

Article V. Preemptive Rights
