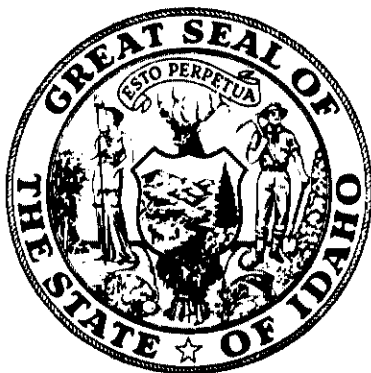

SIXTH: There are no suits pending against the Corporation in any court in respect of which adequate provision has not been

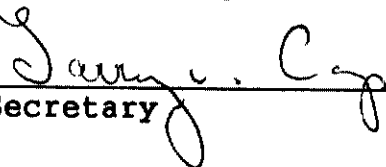
made for the satisfaction of judgment, order or decree which may be entered against it.

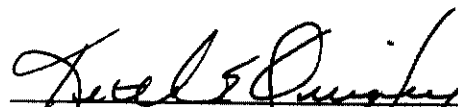
