ARTICLES OF INCORPORATION

OF

SCOTTISH RITE MASONIC CENTER, INC.

We, the undersigned, Frank H. Davison, Alton J. Heath, Clifford A. Maulsby, A. Dale McMurtrey, Wm. F. Gigray, Jr., Wm. T. Haney, N. L. Terteling, C. Ralph Rudolph, and Paul O. Varner, being natural persons of full age and citizens of the United States of America, pursuant to and in conformity with the authority vested in us by the four coordinate Boise Bodies of the Ancient and Accepted Scottish Rite of Free Masonry in the State of Idaho, viz., Boise Lodge of Perfection, Boise Chapter of Rose Croix, Boise Council of Kadosh, and Boise Consistory, by virtue of a resolution duly adopted by said Bodies, a true copy of which resolution is hereunto attached and by reference made a part hereof, do hereby associate ourselves together to form a non-profit corporation under and by virtue of the laws of the State of Idaho, pecuniary profit not being our object, and we do hereby certify:

ARTICLE I

NAME

The name of this corporation is

SCOTTISH RITE MASONIC CENTER, INC.

and it may be commonly known and designated as

THE MASONIC CENTER.

ARTICLE II

DURATION

The duration of this corporation shall be perpetual.

ARTICLE III

PRINCIPAL PLACE OF BUSINESS

The location and postoffice address of the registered office and principal place of business of this corporation shall be in Boise, Idaho.

ARTICLE IV

PURPOSES

The purposes for which the corporation is formed and the objects to be carried on by it are:

Section 1. This corporation does not contemplate and is not formed for pecuniary gain, profit, or benefit. All property, proceeds and income of the corporation shall be devoted to its purposes and objects, and shall not at any time, either while doing business or in the event of voluntary or involuntary dissolution, pass or revert to, or result in, pecuniary profit or gain to the corporation, or to any member thereof.

Section 2. To acquire, maintain, lease, rent, convey, hypothecate, administer, and otherwise deal in lands, buildings, appurtenances, gifts, devises, bequests, funds, endowments and personalty wherewith to create and maintain a Center of Masonic culture and development, for the use and occupation in whole or in part by all lodges, bodies, and organizations identified with the principles and objects of Free Masonry, including all youth organizations, lodges, and bodies sponsored by Masonic Orders, and including a retirement home for aged and disabled members of Masonic Orders and members of their families, as may be authorized and sanctioned from time to time by the four coordinate Boise Bodies of the Ancient and Accepted Scottish Rite of Free Masonry.

Section 3. To create a fund, permanent endowment in character, consisting of properties, both real and personal, the principal thereof to remain intact, and only the incomes to be used for maintenance, upkeep and operation of the corporation's lands, buildings, structures, plants, and personalty.

Section 4. To purchase or otherwise acquire, and accept by deed, purchase, devise, bequest, gift, or otherwise, real and personal property, and to hold, maintain, administer, invest, re-invest, lease, rent, hypothecate, and dispose of the same as may appear to be in furtherance of the purposes and objects and for the best interests of the corporation.

Section 5. To enter into all manner of contracts and transactions designed to accomplish and effect the creation, acquisition, construction, maintenance, upkeep, operation, administration
and disposition of the corporation's properties, and administration and disposition of its funds.

Section 6. To act as a repository of the titles of all properties, both real and personal, acquired by the corporation, to be held by it in fee, but nevertheless in trust, for the use and benefit of the four coordinate Boise Bodies of the Ancient and Accepted Scottish Rite of Free Masonry in the State of Idaho.

Section 7.

(a) To use the corporation's funds and properties exclusively for the corporation's purposes and objects so that no part thereof, either while doing business or upon voluntary or involuntary dissolution, shall inure to the benefit of any member or individual having a personal or private interest in the corporation's activities; and no substantial part of the corporation's funds shall be used to carry on political propaganda or

otherwise to influence legislation; and the corporation shall not participate or intervene in, nor publish or distribute statements concerning, any political campaign, on behalf of any candidate for public office.

- (b) In the event of dissolution of the corporation, after the payment and satisfaction of all its debts, its remaining assets and funds shall be conveyed or transferred to The Supreme Council (Mother Council of the World) of the Inspectors General Knights Commanders of the House of the Temple of Solomon of the Thirty-third Degree of the Ancient and Accepted Scottish Rite of Free Masonry of the Southern Jurisdiction of the United States of America, the headquarters of which are 1733 16th St., N.W., Washington, D.C.
- (c) In no event shall any funds or property of the corporation be distributed or revert to any member, officer, director or trustee of the corporation.

Section 8. In pursuance of and not in limitation of the aforesaid purposes and objects, the corporation shall also have power:

- (a) To do all such acts as are necessary or convenient to ν attain its purposes and objects, to the same extent as any natural person could or might do, and as are not forbidden by law or by these Articles of Incorporation or by the By-laws.
- (b) To exercise and enjoy all of the powers, rights and privileges granted to, or conferred upon, corporations of a similar character by the corporation laws of the State of Idaho now or hereafter in force; the enumeration of the aforesaid powers shall not be deemed to exclude any power, right, or privilege so granted or conferred.

ARTICLE V

MEMBERS

Each member in good standing in the four coordinate Boise Bodies of the Ancient and Accepted Scottish Rite of Free Masonry in the State of Idaho, viz., Boise Lodge of Perfection, Boise Chapter of Rose Croix, Boise Council of Kadosh, and Boise Consistory, shall, by virtue of that membership, be a member of the corporation. The voting rights of all members shall be equal.

ARTICLE VI

DIRECTORS

Section 1. The number of directors constituting the Board of Directors of this corporation shall be not less than five nor more than fifteen, as may be fixed by the By-laws.

Section 2. The names of the persons who have been designated by the four coordinate Boise Bodies of the Ancient and Accepted Scottish Rite of Free Masonry in the State of Idaho, i.e., Boise Lodge of Perfection, Boise Chapter of Rose Croix, Boise Council of Kadosh, and Boise Consistory, to act in the capacity of directors until the election of their successors, are:

Section 3. Qualifications of directors, their terms of office, manner of election, time, place, and manner of calling meetings, and their powers and duties, may be prescribed by the By-laws.

ARTICLE VII

OFFICERS

Section 1. The directors, within thirty days after the formation of this corporation, shall organize by election of the officers of the corporation, to serve until their successors are elected and qualified.

Section 2. The officers and their duties shall be as set forth in the corporation's By-laws.

ARTICLE VIII

BY-LAWS

The Board of Directors of the corporation shall have full power to adopt, amend, or repeal, the By-laws and to adopt new By-laws of the corporation, provided, that such By-laws and amendments shall not be in conflict with the provisions of these Articles of Incorporation, and are consonant with the purposes and objects of the corporation.

ARTICLE IX

AMENDMENT OF ARTICLES

These Articles of Incorporation, except Article IV, Section 7, hereof, may be amended by a vote of two-thirds (2/3) of the directors of the corporation present at any special meeting of the directors called and held for that purpose,

provided, that any such amendment is consonant with the purposes and objects of the corporation, and provided further, that any such amendment be approved by the Sovereign Grand Inspector General, or Deputy of the Supreme Council, in Idaho.

ARTICLE X

ORGANIZATIONAL MEETING

A meeting of the four coordinate Boise Bodies of the

Ancient and Accepted Scottish Rite of Free Masonry in the State of Idaho, i.e., Boise Lodge of Perfection, Boise Chapter of Rose

Croix, Boise Council of Kadosh, and Boise Consistory, was held

at the Scottish Rite Building, 1409 Bannock Street, Boise, Idaho,
on Thursday, the 14th of April, 1966, at 8:00 p.m., for the purpose of authorizing the formation of a non-profit corporation

under the laws of the State of Idaho, to be known as Scottish

Rite Masonic Center, Inc.; also for the purpose of electing
nine (9) directors empowered to draft, execute and file the
corporation's Articles of Incorporation and to adopt its by-laws,
and to serve as the corporation's first Board of Directors, which
directors were elected on the following basis of Lodge representation, to-wit:

Four directors, the presently acting Masters of the four coordinate Boise Bodies of the Ancient and Accepted Scottish Rite of Free Masonry in the State of Idaho;

Four directors, one elected by each coordinate Body, i.e., one by Boise Lodge of Perfection; one by Boise Chapter of Rose Croix; one by Boise Council of Kadosh; and one by Boise Consistory;

One director, in the person of the Sovereign

Grand Inspector General, or Deputy of the Supreme Council, in Idaho;

they to serve until their successors are duly elected and qualified, and as may be provided by the By-laws; that notice of such meeting was given to the members of the four coordinate Boise Bodies of the Ancient and Accepted Scottish Rite of Free Masonry, to be held for the purposes as set forth in the resolution adopted at said meeting; that a copy of the notice so given, and mailed to the members of the said four coordinate Boise Bodies of the Ancient and Accepted Scottish Rite of Free Masonry, is hereunto attached, marked Exhibit A, and by reference made a part hereof; that at said meeting, a resolution was duly and unanimously adopted authorizing the formation of such corporation and adoption of its Bylaws by the directors so elected, a true copy of which resolution is hereunto attached marked Exhibit B and by reference made a part hereof; that at such meeting, there was present a quorum of the members of the said four coordinate Boise Bodies of the Ancient and Accepted Scottish Rite of Free Masonry who unanimously voted in favor of the adoption of said resolution.
