9 corporation, hereby certify that at a regular meeting of the members of  
10 this corporation duly called and held on the 15th day of March  
11 1970, after notice was published in the Buhl Herald, a newspaper published  
12 in Buhl, Idaho for four consecutive weeks and also posted in a conspicuous  
13 place on the Church building for a like period in accordance with the statute  
14 of the State of Idaho, the following resolutions were adopted by the vote of  
15 more than a two-thirds majority of the members of this corporation present  
16 at this regular meeting, the resolutions being as follows:


