#### ARTICLES OF AMENDMENT

to the

#### ARTICLES OF INCORPORATION

of

### SAMURAI, LTD.

Pursuant to the provisions of Section 30-1-61 Idaho Code, Samurai, Ltd., adopts the following Article of Amendment to correct a misstated filing of January 16, 1997.

- On January 8, 1997 a Special Meeting of the Shareholders of Samurai, Ltd., was held
  in corporate offices in Long Beach, California. In accordance with Section 30-1-31
  Idaho Code, the Corporate Secretary, Harry Weed, made and submitted to the
  shareholders present a complete record of the shareholders entitled to vote at said
  meeting, arranged in alphabetical order, with the address and number of shares held by
  each. Said record showed that there were 100,000 voting shares issued and entitled to
  vote.
- 2. The record was produced and kept open at said meeting and was subject to the inspection of the shareholders during the whole of the meeting.
- 3. A motion was made to amend paragraph 6 of the Articles of Incorporation, which motion was defeated by the vote of 51,000 shares Against the passage thereof.
- 4. The purported Amendment to the Articles of Incorporation dated January 9, 1997 and inappropriately filed January 16, 1997 is therefore void and of no effect.

- 14 MR. LARKIN: That objection is noted.
- 15 MR. WEED: It's not an objection.
- MR. LARKIN: I move that the articles of incorporation be
- 17 amended as discussed, effective immediately. Is there a
- 18 second?
- 19 MR. EDWARDS: I second.
- MR. LARKIN: It has moved and seconded that the articles
- 21 of incorporation be so amended. Would all those in favor so
- 22 signify by saying aye. Aye.
- MR. WEED: 51,000 shares of stock vote no.
- MR. LARKIN: All those opposed by saying no.
- MR. WEED: 51,000 shares vote no.
