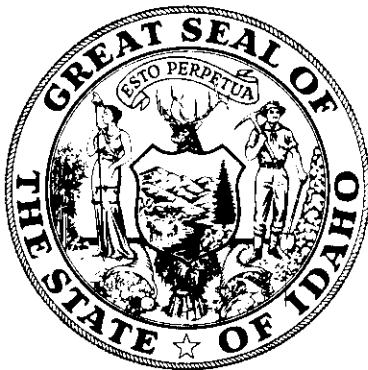

ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
AGRI-CHEMICAL COMPANY, INC.

WE, the undersigned, being all of the incorporators and directors of AGRI-CHEMICAL COMPANY, INC., an Idaho corporation, and having duly adopted and approved a resolution for amending the Articles of Incorporation of said corporation, do hereby execute these Articles of Amendment to the Articles of Incorporation of AGRI-CHEMICAL COMPANY, INC.

I.

The name of the corporation is AGRI-CHEMICAL COMPANY, INC.

II.

The resolution approved and adopted amends Article III of the original Articles of Incorporation to read as follows:

The capital of this corporation shall be divided into Sixty Million (60,000,000) shares of \$0.01 par value common stock, for a total authorized capital of Six Hundred Thousand Dollars (\$600,000.00). The holders of the common stock of this corporation shall have one vote for each share on all matters submitted to a vote of the shareholders, but such voting rights shall be non-cumulative.

III.

The resolution adopting said amendment to the Articles of Incorporation was duly adopted by the Board of Directors on the 25th day of March, 1983.

IV.

As of the date of these Articles of Amendment, none of the shares of stock authorized by the original Articles of Incorporation have been issued, and there are no shares of this corporation outstanding.

V.

The amendment so adopted by the Board of Directors increases the stated capital of this corporation from Fifty and no/100 Dollars (\$50.00) to Six Hundred Thousand and no/100 Dollars (\$600,000.00), and increases the number of shares of common stock which this corporation is authorized to issue from Five Thousand (5,000) to Sixty Million (60,000,000).
