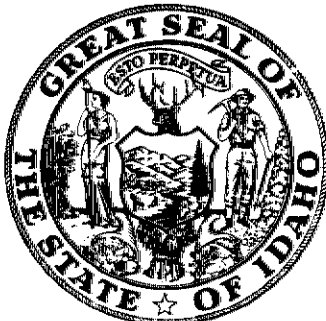

The Articles of Incorporation of Hammond Hauling, Inc., are hereby amended to correct paragraph 3, Purposes. Paragraph 3 is the only change. In all other respects, the Articles of Incorporation filed with the Secretary of State on January 13, 1997 will remain the same.

The following Articles of Incorporation are hereby adopted pursuant to the Idaho Business Corporation Act:

1. Name.

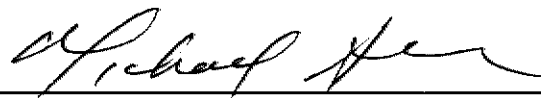
