



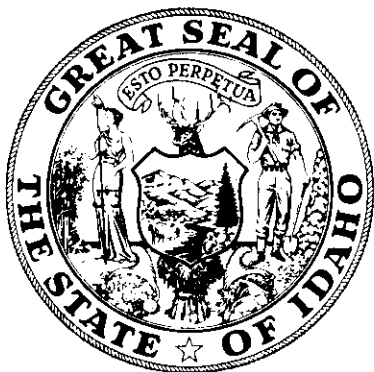

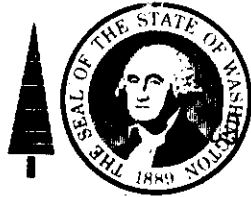

ARTICLES OF INCORPORATION

OF

G. L. KEYES CONSTRUCTION, INC.

THESE PRESENTS WITNESS: That I, the undersigned, being desirous of forming a corporation for the purposes hereinafter specified and in conformity to the laws of the State of Washington, do hereby make and subscribe the following written Articles of Incorporation in triplicate:

ARTICLE I

The name of this corporation shall be G. L. KEYES CONSTRUCTION, INC.

ARTICLE II

The time of existence of this corporation shall be perpetual.

ARTICLE III

The purpose of this corporation is to engage generally in the business of construction contracting of every kind and in furtherance thereof generally engage in, do and perform, any enterprise, act or vocation that a natural person might or could do or perform; to acquire, own and hold such real and personal property as may be necessary or convenient for the transaction of its business or for investment purposes and to mortgage and encumber the same and to deal generally therein.

ARTICLE IV

The capital stock of this corporation shall consist of 1,000 shares of common stock with no par value.

ARTICLE V

The aggregate value of the shares of common stock will not be in excess of \$50,000, and the aggregate value of all stock issued will not be in excess of \$50,000.

ARTICLE VI

This corporation will not commence business until consideration of the value of at least \$500.00 has been received for the issuance

of shares.

ARTICLE VII

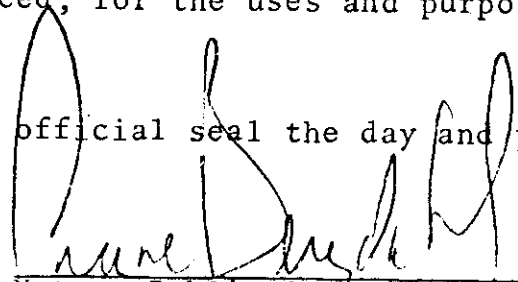

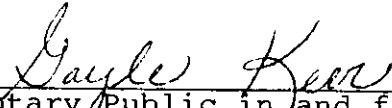
