ARTICLES OF INCORPORATION OF

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of legal age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, do hereby certify as follows:

I.

Name

The name of the corporation shall be Heart Diamond, Inc.

II.

Registered Office

The location and post office address of the registered office of the corporation shall be Star Route, Box 87-A, Melba, Idaho 83641.

III.

Registered Agent

The name of the registered agent of the corporation is Duane Jacobson.

IV.

Duration

The period of existence and duration of the corporation shall be perpetual.

ARTICLES OF INCORPORATION - 1

Corporate Purpose

The purpose for which the corporation is organized shall be the transaction of any and all lawful business for which corporations may be incorporated under the laws of Idaho.

VI.

Authorized Capital Stock

The corporation shall have 1,000 shares of no par value common stock. Each share shall have the same rights, privileges and voting power and shall be nonassessable.
