



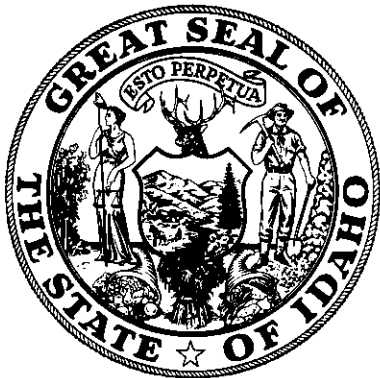
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION RECEIVED

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following articles of incorporation for such corporation as follows:

FIRST

The name of the corporation is MOSES, INC.

SECOND

The period of its duration is perpetual.

THIRD

The purpose or purposes for which this corporation is formed are to transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

a. This corporation shall have perpetual succession by its corporate name.

b. To sue and to be sued, appear, complain and defend in any court of law or equity, or before any board, commission, or tribunal, in its corporate name.

c. To have a corporate seal which may be altered at pleasure, and to use the said seal by causing it, or its facsimile, to be impressed or affixed or in any other manner reproduced.

d. To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use and other deal in and with,

real or personal property, or any interest therein, wherever situated.

e. To sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of all or any part of this corporation's property and assets.

f. To lend money and use its credit to assist its employees.

g. To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships, or individuals or direct or indirect obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other government, state, territory, governmental district or municipality or of any instrumentality thereof.

h. To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises and income.

i. To lend money for its corporate purposes, invest and reinvest its funds, and take hold real and personal property as security for the payment of funds so loaned or

invested.

j. To conduct its business, carry on its operations and have offices and exercise the powers granted by this act, within or without this state.

k. To elect or appoint officers and agents of the corporation, and define their duties and fix their compensation.

l. To make and alter by-laws, not inconsistent with its Articles of Incorporation or with the laws of this state, for the administration and regulation of the affairs of the corporation.

m. To make donations for the public welfare or for charitable, scientific or educational purposes.

n. To transact any lawful business which the board of directors shall find will be in aid of governmental policy.

o. To pay pensions and establish pension plans, stock option plans and other incentive plans for any or all of its directors, officers and employees.

p. To be a promoter, partner, member, associate, or manager of any partnership, joint venture, trust or other enterprise.

q. To have and exercise all powers necessary or convenient to effect its purpose.

The objects and purposes specified in the foregoing clauses shall, except where otherwise expressed, be in no wise limited or restricted by reference to, or inference from the terms of any other clause in these Articles of

Incorporation, but the objects and purposes specified in each of the foregoing clauses of this article shall be regarded as independent objects and purposes.

FOURTH

The aggregate number of shares which the corporation shall have the authority to issue is 50,000, which shares shall have no par value.

FIFTH

No common stock of this corporation shall be transferred on the books of the corporation to anyone not a stockholder or an heir of a stockholder, without the written consent of all common stockholders, unless the common stock shall first be offered for sale to the corporation and secondly to each of the other common stockholders of this corporation at a price and by a method to be determined by the rules and procedures outlined in the by-laws of this corporation. The by-laws of this corporation shall further prescribe the rules and regulations as to the formalities and procedures to be followed in effecting the transfer of common stock to anyone other than a common stockholder. On the face of each and every certificate of stock issued by this corporation shall be printed a notice as follows:
"Transfer of stock restricted by By-Laws".

SIXTH

The address of the initial registered office of the corporation is 421 E. Dakota Avenue, Hayden Lake, Idaho, 83835, and the name of its initial registered agent at such address is Adrian Moses.

SEVENTH

Number of directors constituting the initial Board of Directors of the corporation is five (5), except, until the first annual meeting of shareholders, when directors may be elected, Adrian Moses shall serve as the sole director of the corporation, 421 E. Dakota Avenue, Hayden Lake, ID. 83835.
