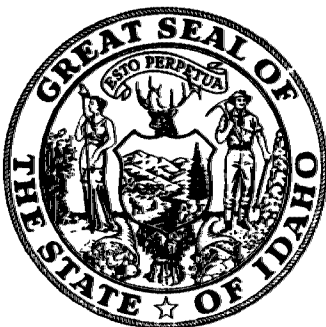

ARTICLES OF INCORPORATION

That the undersigned, desiring to become incorporated and to obtain the benefits conferred on a corporation by law, hereby enters into the following Articles of Incorporation, the terms of which shall be equally obligatory upon the parties hereto as well as upon all other person who from time to time may be stockholders in the corporation.

A. The name of the corporation shall be:

RP ENTERPRISES, INC.

B. The duration of the corporation shall be perpetual.

C. The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

D. The authorized stock of the corporation shall consist of one class only of 1,000 shares of a par value of \$1.00 each, with an aggregate par value of \$1,000.00. Stockholders shall have full pre-emptive rights.

E. The corporation may purchase and redeem its own shares at any time so long as one share remains issued and outstanding after such purchase and redemption. No shares of the corporation shall be sold or transferred to any not designated by the Board of Directors until the corporation and the remaining stockholders have been afforded an opportunity to buy the stock on the terms set forth in the By-Laws of the corporation and/or in any stock redemption agreement.

F. The place of the ^{registered} principal office of the corporation shall be:
