

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

1st. That the name of said corporation is the "Acme Gold Dredging Company" (Limited).

2nd. That the purposes for which it is formed is to carry on the business of mining for gold along and upon the Snake River within the State of Idaho and to acquire all necessary machinery, boats, dredges and other apparatus together with placer mining ground necessary for the conducting of said business.

3rd. That the place where its principal business is to be transacted shall be the City of Pocatello, Bannock County, State of Idaho.

4th. That the term for which it is to exist is Fifty years from and after the date of its incorporation.

5th. That the number of its Directors shall be Five, and that the names and residences of those who are appointed for the first year are:
