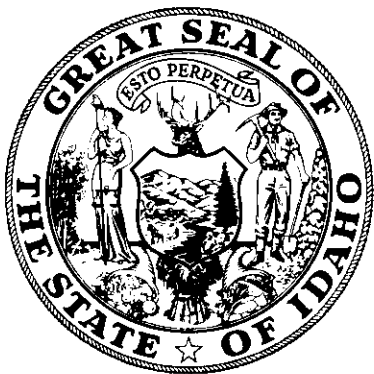

ARTICLES OF INCORPORATION

Know all men by these presents, that we, the undersigned residents of Shoshone County, State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

Article I

That the name of the corporation shall be The North Idaho Chaplains Corps Incorporated.

Article II

That the purposes for which said corporation is to be formed by the members of The North Idaho Chaplains Corps Incorporated, is for the religious and charitable purposes and is a non-profit corporation, and for the main and more specific purpose of ministering the Gospel to persons incarcerated in County Jails and State Penitentiaries and their families.

Article III

That the present Directors of The North Idaho Chaplains Corps Incorporated is to remain as such until such time that either one or both may see fit to resign from such Directorship.

Article IV

That period for which this corporation is formed is for fifty years.

Article V

That the location of the corporation is 307 S. Division St. Kellogg, Shoshone County, State of Idaho.

Article VI

The corporation officers will be: two Co-Directors, a Secretary, and a Treasurer.

Article VII

Services will be held at the County Jails and State Prisons in accordance with the facilities rules and regulations for such services.

Article VIII

The North Idaho Chaplains Corps officers will serve as the board of Directors for the membership of said corporation and will work in close agreement with the local Ministerial Association.

Article IV




