ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

of

WALSTON, SPACKMAN & BALLARD, P.A.

Pursuant to the provisions of Section 30-1-58 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Walston & Spackman, P.A.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on June 29, 1982, in the manner prescribed by the Idaho Business Corporation Act:

ARTICLE 1

The name of the corporation is Walston & Spackman, P.A.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 903 and the number of shares entitled to vote thereon was 903.

FOURTH: The number of shares voted for such amendment was 903; and the number of shares voted against such amendment was none.

FIFTH: The manner in which any exchange, reclassification, or cancellation of issued shares provided for in the amendment shall be effected is as follows:
