Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The present name of the corporation is TELLOW PAGES, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation of August 1, 1984, in the manner prescribed by the Idaho Business Corporation Act:

### ARTICLE I

The name of the corporation is TELLO PAGES CONSUMER INFORMATION SERVICE, INC.

#### ARTICLE V

The amount of the capital stock of the corporation shall be, and is, \$5,100.00, divided into 5,100 shares. Each such share shall have a par value of \$1.00. Said stock shall be, and is, nonassessable.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 100; and the number of shares entitled to vote thereon was 100.

FOURTH: The number of shares voted for such amendment was 100; therewere no votes against the amendment.

FIFTH: The manner in which such amendment affects a change in the amount of stated capital, and the amount of stated capital as changed by such amendment as are follows:

The amount of stated capital is increased by \$5,000.00 by authorizing an additional 5000 shares at a par value of \$1.00.
