## ARTICLES OF AMENDMENT

OF

Pursuant to the provisions of the Idaho Business Corporation Act, Video Graphic Styling, Inc. adopts the following Articles of Amendment to its Articles of Incorporation:

I.

The name of this corporation is VIDEO GRAPHIC STYLING, INC.

II.

The following amendment to the Articles of Incorporation was adopted by the stockholders of the corporation on November 31d, 1986, in the manner prescribed by the laws of the State of Idaho, and the By-laws of the corporation:

> "RESOLVED That paragraph I. of the Articles of Incorporation of Video Graphic Styling, Inc., which presently reads as follows:

be amended to read as follows:

That the name of this corporation is Video Graphic Systems, Inc."
