ARTICLES OF INCORPORATION

- ARTICLE I. Name of Corporation: Bible Baptist Church, INC.
- ARTICLE II. The Bible Baptist Church is a nonprofit corporation.
- ARTICLE III. The Bible Baptist Church is a perpetual corporation.
- ARTICLE IV. Purposes and Objects:

The purposes for which the corporation is organized are: to organize a congregation of unaffiliated Christian persons to promote the entity of Christian faith as set forth in the Holy Scriptures of the Old and New Testaments, and for the enjoyment of all privileges and duties given by God in His Word, including those for which provision is made by the laws of this State, including but not limited to the following:

- Establishing and maintaining worship services;
- Establishing and maintaining Christian schools, colleges, seminaries, academies, vocational training institutes, pre-school ministries, and other Christian education ministries;
- 3. Establishing and maintaining Christian publishing ministries, in order to promulgate the faith;
- 4. Establishing and maintaining Christian hospitals;
- 5. Establishing and maintaining Christian broadcasting programs or ministries, including operation of radio or television stations;
- 6. Establishing and maintaining "bus ministries";
- Establishing and maintaining prayer meetings, prayer services, Bible studies and Sunday schools;

- 8. Distributing God's Word, the Holy Bible, to any and all persons; and all other activities which are mandated or permitted by God in His Word, the Holy Bible;
- 9. The purchase, holding, administering upon and selling of property of every description and the accepting, the holding and administering upon legacies, donations, commercial papers to the corporation in the carrying out of its work described above.

The purpose of the corporation is not to obtain profit or pecuniary gain to members thereof.

- ARTICLE VI. The Bible Baptist Church shall have members and the management of the affairs of said corporation shall be vested in its membership.
- ARTICLE VII. This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation, nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

The property of this corporation is irrevocably dedicated to the purposes set forth in Article IV of these Articles of Incorporation, and no part of the net income or assets of this corporation shall ever enure to the benefit of any director, officer, or member thereof, or the benefit of any private individual or donor to the corporation.

Upon dissolution or winding up of this corporation, its assets remaining after payment or provision of payment for all debts and liabilities of the corporation, shall be distributed to a non-profit fund, foundation, or corporation which is organized exclusively for purposes consistent with these Articles of Incorporation and in agreement with the doctrinal statement contained in these Articles and which is recognized, or eligible for recognition, by the Internal Revenue Service of the United States as one organized exclusively for religious, missionary, or educational purposes and which has established, or is eligible to establish, tax exempt status under Section 501(c) (3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws.

The corporation shall have a racially non-discriminate policy as to students, therefor shall not discriminate against applicants and students on the basis of race, color or ethnic origin.

The street address of the Bible Baptist Church is ARTICLE VIII. 1015 Burrell Avenue, Lewiston, Idaho, 83501. The initial registered agent is Pastor Richard C. Moore.
