



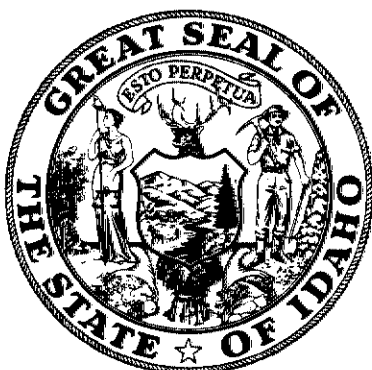
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
SECRETARY OF STATE
OF

STONERIDGE RECREATIONAL CLUB CONDOMINIUM

We, the undersigned persons, acting as the incorporators of a corporation under the Idaho Nonprofit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this Corporation shall be "STONERIDGE RECREATIONAL CLUB CONDOMINIUM OWNERS ASSOCIATION, INC."

ARTICLE II

The Corporation is a nonprofit corporation and the period of duration of the Corporation shall be perpetual.

ARTICLE III

Members of this Corporation shall constitute the owners of Stoneridge Condominium time-share units and its purpose shall be to manage, maintain and administer the affairs of the condominium project.

ARTICLE IV

The Corporation shall have one class of membership. Voting rights shall be apportioned on the basis of ownership of a time-share unit in the Stoneridge Condominium project. Each time-share unit shall represent one voting membership and entitle the owner or owners of that unit to one membership vote.

ARTICLE V

1. The location and post office address of the registered office of this Corporation in this state shall be Stoneridge Condominium Office, Blanchard Road, P. O. Box 135, Blanchard, ID 83804.

2. The registered agent of this Corporation at that address shall be Cindy Thomas.

ARTICLE VI

1. The number of Directors constituting the initial Board of Directors of this Corporation shall be FIVE (5) in number.

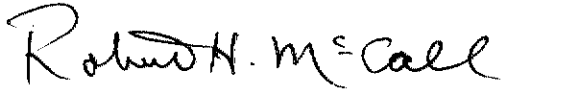
