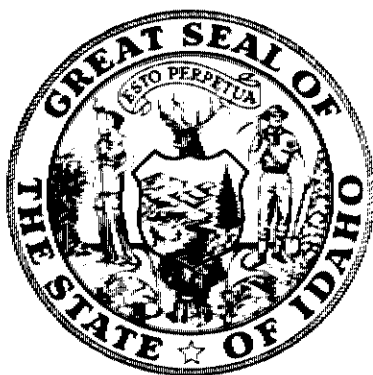

AMENDMENT TO ARTICLES OF INCORPORATION

Pursuant to Section 30-1-61 of the Idaho Code of the Idaho Business Corporations Act, the undersigned corporation adopts the following Amendment to its Articles of Incorporation:

1. The name of the corporation is MLD, INC.
2. The following amendment to the Articles of Incorporation was adopted by the Shareholders of MLD, INC. on the 23 day of Feb, 1988, in the manner prescribed by the laws of the State of Idaho.

Resolved that Article I of the Articles of Incorporation, be amended to read as follows:

That the corporate name of this corporation shall be: M.L.D., INC.
