AMENDED AND RESTATED ARTICLES OF INCORPORATION OF BARRY HOOPES INSURANCE AGENCY, INC.

Pursuant to the provisions of Idaho Section 30-1-59 and 30-1-64 of the Idaho Business Corporation Act and resolutions duly adopted by its directors and shareholders, Barry Hoopes Insurance Agency, Inc., adopts the following restated articles of incorporation:

> 1. Amendment to the Articles of Incorporation:

RESOLVED, the articles of incorporation be amended by deleting all of the provisions of the articles filed with the Idaho Secretary of State on March 3, 1982, and inserting the following in lieu thereof:

- The name of the corporation is the David Leonardson Insurance Agency, Inc.
- 2. The period of its duration is perpetual.
- 3. Its purpose is to transact the business of:
 - A general lines agent, broker Α. and/or consultant transacting any one or more of the following kinds of insurance under license issued pursuant to Idaho Code Title 41: property, casualty, surety, marine and transportation, and/or disability.
 - В. A life agent, broker and/or consultant transacting one or more of the following items: items under license issued pursuant to Idaho Code Title 41: Life insurance, annuity business and/or disability insurance.
 - All other purposes not forbidden by law.
- 4. Shall have authority to issue 10,000 shares all in one class, one dollar par value.

- 5. The address of its initial registered office was Main Street, Dubois, Idaho 83423 and the name of its initial registered agent at such address was Barry L. Hoopes.
- 6. The number of directors constituting its initial board of directors was two whose names and addresses are: Barry L. Hoopes and Judy K. Hoopes, Center and Evans Street, Dubois, Idaho 83423.
- 7. The principal place of business of the corporation shall be maintained in the State of Idaho.
- 8. The name and address of its initial incorporators were: Barry L. Hoopes and Judy K. Hoopes, Center and Evans Street, Dubois, Idaho.

These restated articles correctly sets forth without change the corresponding provisions of the Articles of Incorporation and as herefore amended and incorporates the following amendments:

On September 25, 1987, all of the original articles were deleted and in replacement the restated articles as set forth above where substituted:

The foregoing amendments were adopted by the unanimous consent of the shareholders and directors dated September 25, 1987. 5,000 shares, common were outstanding on that date. All voted in favor of the amendments. None voted against.

The restated articles of incorporation together with the designated amendments supersede the original articles of incorporation and all amendments thereto.
