ARTICLES OF INCORPORATION  
OF  
PETERSON'S COIN-OP. AND HOBBY SHOP, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are citizens of the United States of America, residents of the State of Idaho, and of legal age, have today voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

I.

The name of the Corporation shall be "PETERSON'S COIN-OP. AND HOBBY SHOP, INC."

II.

The duration of the Corporation shall be perpetual.

III.

The location and post office address of the registered office of the Corporation in the State of Idaho shall be 190 South 2nd East, Soda Springs, Caribou County, Idaho.

IV.

The authorized capital stock of the Corporation shall consist of Fifty (50) shares of no par value common stock. All of the stock shall be of the same class, have the same powers and voting rights and shall not be assessable for any purpose whatsoever.

V.

The business of this Corporation shall be managed by a Board of Directors consisting of no less than three (3) Directors.

The qualifications, the term of office, manner of electing directors, the number of directors to be elected, the time, place and manner of calling meetings, and the powers and duties of the directors shall be prescribed by the By-Laws. The names and post office addresses of the Directors until the first annual meeting of the stockholders are as follows:

## VI.

The purposes for which said Corporation is organized are as follows:

A. To operate coin-operated laundries and dry-cleaning establishments, hobby and craft shops, gifts and gift-ware, furnishings, pictures and general merchandising establishments; to do and perform all and every kind of laundry work and services, wet wash, rub dry, finished and unfinished and any and all work incidental thereto for the trade at retail and wholesale; and to dry-clean and renovate wearing apparel, clothes and fabrics of any kind for hire and all businesses incidental thereto.

B. To manufacture, purchase and sell notions, toys, department store supplies, gifts, giftwares, hobby and craft shop supplies and merchandise of every kind and to receive and sell the same as agent or on commission.

C. To purchase, own, sell and to deal in all types of laundry and dry-cleaning equipment and personal property and to hypothecate same; to deal in, lease and broker leases for all types of laundry and dry-cleaning equipment and personal property.

D. To buy, own, sell, hypothecate and to have the power to do each and everything necessary to deal in real property.

E. To acquire and take over as a going concern and thereafter to carry on the business of any person, firm or corporation engaged in any business which this Corporation is authorized to conduct and in connection therewith, to acquire the good will and all or any of the assets and to conduct or otherwise provide for all or any of such businesses.

F. To borrow money for its corporate purposes and to make, accept, endorse, execute and issue promissory notes, bills of exchange, bonds, debentures or other obligations from time to time for the purchase of property for any purpose in or about the business of the Corporation, and if deemed proper, to secure the payment of any such obligations by mortgage, pledge, deed of trust, or otherwise.

G. To enter into, make, perform and carry out contracts of every sort and kind which may be necessary and convenient for the business of the Corporation with any person, firm, corporation, association, body politic, state or other form of government so far as and to the same extent that the same may be done and performed by corporations organized under the laws of the State of Idaho.

H. To act as employee, agent, trustee, receiver, liquidator, manager or broker or in any other capacity with respect to the establishment or promotion of corporations, associations, undertakings, businesses or enterprises of any description; to purchase, lease, own, acquire, deal in, sell, convey or assign any rights, franchises or privileges necessary or convenient in the creation, establish-

ment, promotion or liquidation of enterprises, businesses or undertakings.

I. To buy, sell, discount and deal in all types of securities, whether negotiable or otherwise, including, but not limited to, bills of exchange, notes, bonds, debentures, warrants and certificates; to borrow or loan money and to give or receive security therefor by mortgage, pledge or in any other fashion authorized by law.

J. To carry on a general manufacturing, wholesale, and retail merchandising business; to purchase or deal in or dispose of patents, patent rights, licenses, trade-marks, trade-names, and secret devices or processes of every kind or description; to own, acquire, buy, sell, and otherwise deal in real estate of all kinds including water rights, ditches, canals, and other appurtenances to real estate.

K. To have the powers and to do those acts, things, and deeds set forth in Section 30-114, Idaho Code, and any and all amendments thereto.

L. To do all acts and things necessary to carry out the purposes and intent expressed in the above provisions, and each and every necessary, suitable or advisable act or thing for the accomplishment thereof.

## VII.

The power to repeal and amend the By-Laws and adopt new By-Laws is hereby conferred upon the Directors, as well as upon the shareholders, to be exercised by such vote of the Directors or of the allotted shares as the case may be; provided, however, not less

than a majority thereof as may be fixed by the By-Laws.

VIII.

No contract or other transaction between the Corporation or any other corporation, whether or not a majority of the shares of the capital stock of such other corporation is owned by the Corporation, and no act of the Corporation shall in any way be affected or invalidated by the fact that any of the Directors of the Corporation are pecuniarily or otherwise interested in, or are Directors or officers of such other corporation; any Director individually may be a party to or may be pecuniarily or otherwise interested in any contract or transaction of the Corporation and any Director of the Corporation who is so interest may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the Company which shall authorize such contract or transaction and may vote thereon to authorize such contract or transaction with like force and effect as if he were not such Director or officer of such other Corporation and not so interested.
