ARTICLES OF AMENDMENT
OF

THE VOICE OF GARDEN CITY, INC.

The undersigned, acting as the incorporators of a nonprofit corporation ("Corporation") organized under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code ("Act"), adopts the following Articles of Amendment for the Corporation.

ARTICLE IV. PURPOSES

The Corporation is organized and shall be operated exclusively for assisting urban renewal planning within the city limits of Garden City, Idaho, within the meaning of Section 5011(c)(6) of the Internal Revenue Code of 1986.

Without limiting the generality of the foregoing, the purposes of the Corporation shall include the following:

1. To inform, report to, and educate the citizens of Garden City, Idaho concerning urban renewal planning and related activities within the city limits of Garden City, Idaho.

2. To exercise all powers granted by law necessary and proper to carry out the above-stated purposes, including but not limited to the power to accept donations of money, property, whether real or personal, or any other thing of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefor, may not at that time

lawfully carry on or do.

3. To assist the Citizens of Garden City in urban renewal planning, including participation in the Comprehensive Land Use Plan, planning and zoning efforts and the Comprehensive Planning Committee, and such other issues as may become areas of concern for the membership of The Voice of Garden City. The Corporation shall encourage and assist city government, community groups, business groups and/or committees to help plan and promote improvements to Garden City.
