#### ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That O. Wayne Clifford, being over the age of eighteen (18) years, and for the purpose of forming a corporation under the Idaho Business Corporation Act, hereby certifies and adopts, in duplicate, the following Articles of Incorporation:

#### ARTICLE I.

The name of the corporation shall be "Lewiston Auto & R.V., Inc.", and its existence shall be perpetual.

## ARTICLE II.

The purposes for which the corporation is formed are as follows:

- (a) The business of selling and servicing of new and used motor vehicles and recreational vehicles, and all other businesses necessary and incidental thereto.
- (b) To engage in and transact any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
- (c) In furtherance of and not in limitation of the general powers conferred by the laws of the State of Idaho, it is expressly provided that this corporation shall also have the following powers:
  - 1. To acquire, by purchase or otherwise, and to own, hold, cancel, reissue, sell, pledge and otherwise deal in the stock of this corporation; provided, that the money or property of the corporation shall not be used for purchase of shares of its own stock when such use would cause any impairment of the capital of the corporation. The corporation shall not be entitled to vote, either directly or indirectly, on any shares of its own stock which it may hold.
  - 2. To acquire, by purchase or otherwise, and to own, hold, cancel, reissue, sell, pledge and otherwise deal in the bonds, debentures, notes and other securities and obligations of this corporation.
  - 3. To borrow money and give security therefor.
  - 4. To enter into, make, perform and carry out contracts of every kind for any lawful purpose pertaining to its business,

with any individual, entity, firm, association or corporation, or with any governmental, municipal or public authority, domestic or foreign.

- 5. To do everything necessary, proper, convenient or incidental to the accomplishment of the purposes and objects of this corporation, or which is calculated directly or indirectly to promote the welfare or interests of the corporation or enhance the value or render profitable any of its property or rights.
- 6. To do any and all the things in this article set forth to the same extent a natural person might or could do, and in any part of the world, as principals, agents, contractors, trustees or otherwise, either alone or in company with others.

PROVIDED, HOWEVER, that nothing herein contained shall be deemed to authorize or permit the corporation to carry on any business, or to exercise any power, or to do any act which a corporation formed under the Idaho Business Corporation Act or any amendment thereto, or substitute therefor, may not at any time lawfully carry on or do.

#### ARTICLE III.

The address of the initial registered office of the corporation is 1617 21st Street (Post Office Box 606), Lewiston, ID 83501, and the name of the initial registered agent at such address is Robert L. Copeland.

### ARTICLE IV.

The total number of shares of stock authorized and which may be issued by this corporation shall be one hundred thousand (100,000) shares common stock of the par value of One Dollar (\$1) each, the total thereof being One Hundred Thousand Dollars (\$100,000).

## ARTICLE V.

- 1. The number of directors of the corporation shall be fixed as provided by the Bylaws, and may be changed from time to time by amending the Bylaws, as therein provided.
- 2. In furtherance of and not in limitation of the powers conferred by the laws of the State of Idaho, the board of

directors is expressly authorized to make, alter and repeal the Bylaws of the corporation, subject to the power of the stock-holders of the corporation to change or repeal such Bylaws.

- The corporation may enter into contracts and otherwise transact business as vendor, purchaser or otherwise, with its directors, officers and stockholders, and with corporation, associations, firms and entities in which they are or may be or become interested as directors, officers, shareholders, members or otherwise, as freely as though such adverse interests did not exist, even though the vote, action or presence of such director, officer or stockholder may be necessary to obligate the corporation upon such contract or transaction shall be avoided an no such director, officer or stockholder shall be held liable to account to the corporation, by reason of such adverse interests or by reason of any fiduciary relationship to the corporation arising out of such office or stock ownership, for the profit or benefit realized by him through any such contract or transaction; provided, that in the case of directors and officers of the corporation (but not in the case of stockholders who are not directors or officers) the nature of the interest of such director or officer, though not necessarily the details or extent thereof, be disclosed or known to the board of directors of the corporation, at the meeting thereof at which such contract or transaction is authorized or confirmed. A general notice that a director or officer of the corporation is interested in any corporation, association, firm or entity shall be sufficient disclosure as to such director or officer with respect to all contracts and transactions with that corporation, association, firm or entity.
- 4. Any contract, transaction or act of the corporation or of the directors or of any officer of the corporation which shall be ratified at any annual stockholders' meeting or any special stockholders' meeting called for such purpose by the

holders of the majority of the shares entitled to vote at such meeting, shall, insofar as permitted by law, be as valid and as binding as though ratified by every stockholder of the corporation.

- 5. The stockholders of the corporation shall have pre-emptive rights to acquire unissued or treasury shares of the corporation without limitation, in the ratio of their respective stock ownership. No stock shall be offered for sale without offering the same to present stockholders in accordance with the foregoing formula.
