ARTICLES OF INCORPORATION SERVICE TATE

The undersigned, acting as incorporators of a corporation under the Idaho Corporation Act, adopt the following Articles of Incorporation for this corporation.

Τ

The name of this Corporation shall be SUE CHRIS POWER TOOL AND MACHINERY, INC.

ΙI

The period of existence and duration of the life of this corporation shall be perpetual.

III

The address of the initial registered office of this corporation is 3623 Camborne, and the name of the initial Boise, 83704 registered agent at such address is Lola M. Zweifel.

ΙV

The nature of the business and the object and purpose of this corporation shall be as follows:

- (a) Owning, managing and operating a power tool and machinery business; the sale, leasing, servicing of power tools and machinery.
- (b) The transaction of any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLES OF INCORPORATION - 1

That the total authorized number of par value shares of this corporation shall be one hundred thousand (100,000), all of one class, each of a par value of \$1.00, which said shares shall be common stock and shall not be subject to assessment.
