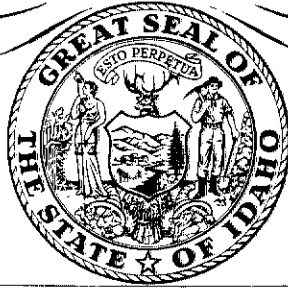

ARTICLES OF INCORPORATION

OF

HarBur-LeEno, Inc.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, each of whom is a bona fide resident and citizen of the State of Idaho, and the United States of America, and each of whom is a natural person of full age, have this day voluntarily associated ourselves together with the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

ARTICLE I

That the name of this corporation shall be:

HarBur-LeEno, Inc.

ARTICLE II

The objects and purposes for which this corporation is formed are: as principal, agent or otherwise, to do in any part of the world any and every of the things herein set forth to the same extent as natural persons might or could do. In furtherance, and not in limitation, of the general powers conferred by the laws of the State of Idaho, we do expressly provide that the corporation shall have power:

(a) To engage in every and all types of enterprise dealing with the use of heavy equipment, trucks, tractors, loaders, and assorted and related machinery and equipment; to lease or sell such equipment and to use such equipment in the furtherance of the corporate business; to engage in the construction of roads, highways, and other diversified enterprises connected with construction; to engage in any and all phases of cutting, transporting, hauling, and merchandising timber and timber products, and to enter into all necessary contracts and agreements to further any of the specifically named business purposes set forth herein.

(b) To enter into, make, perform, and carry out contracts

1 of every kind, amount, and character with any person, firm, asso-
2 ciation, or corporation.

3 (c) To purchase, own, sell, convey, mortgage, pledge,
4 exchange, acquire by operation of law or otherwise, real property
5 of every kind and character, and each and every kind of personal
6 property, debts, dues and demands or choses of action, evidence
7 of debts, bonds, stocks of corporations, both public and private.

8 (d) To borrow and lend money from and to any person, firm,
9 association, and to make, take and execute notes, mortgages,
10 bonds, deeds of trust, or other evidence of indebtedness, to
11 secure payment thereof, or by any other lawful manner or means,
12 and to take and receive notes, bonds, mortgages, deeds of trust,
13 or any evidence of indebtedness, for the use and benefit of
14 said corporation or otherwise.

15 (e) To own, hold, lease or sublet, or to conduct on its
16 own account, or for any person, firm, association or corporation,
17 all and every kind of equipment and machinery.

18 (f) To build any and all necessary shops, buildings, ware-
19 houses, and structures at any place proper or convenient to carry
20 on any or all of the business of said corporation.

21 (g) To purchase or otherwise acquire and own the corporate
22 common and preferred stock and bonds of any other corporation,
23 and also to purchase and acquire its own common stock in so far
24 as not contrary to the laws of the State of Idaho.

25 (h) In addition to the foregoing powers, also to have all
26 authority, powers, and rights granted by the laws of the State
27 of Idaho, and particularly Section 30-114 Idaho Code, and any
28 amendments thereof.

29 (i) In general to transact and do all such matters and
30 things as are or shall be considered as conducive or incidental
31 to each and every of the above purposes, and to conduct and
32 carry on the business for which this corporation is organized
alone and/or with others as co-partners or joint adventurers

1 or otherwise, it being expressly provided that the foregoing
2 enumeration of specific powers shall not be held to limit or
3 restrict in any manner the general powers of the corporation.

4 ARTICLE III

5 The registered office of this corporation and the principal
6 place for transaction of its business is hereby designated as
7 Boise, Ada County, Idaho.

8 ARTICLE IV

9 This corporation shall have perpetual existence.

10 ARTICLE V

11 The number of directors of this corporation shall be not
12 less than three (3) in number.

13 ARTICLE VI

14 The amount of the capital stock of this corporation is Ten
15 Thousand (10,000) shares of common stock, having a par value of
16 \$10.00 per share, and said stock shall be non-assessable.

17 ARTICLE VII

18 The amount of the capital stock actually subscribed is
19 five shares by the persons whose residence and the amounts subscribed
20 herein are set forth:
