ARTICLES OF AMENDMENT OF SILVER STAR-QUEENS MINES, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS, that we, JOE A. FOSTER, President, and R. W. DECKER, Secretary, of SILVER STAR-QUEENS.

MINES, INCORPORATED, a corporation organized and existing under the provisions of the Business Corporation Act of the State of Idaho

DO HEREBY CERTIFY:

FIRST: That a meeting of the stockholders of the above named corporation was held on the 31st day of March 1961, for the purpose of taking action upon a proposed amendment to the Articles of Incorporation of the said corporation, pursuant to twelve days notice stating the specific purpose of the meeting, mailed to all shareholders entitled to vote on the proposed amendment.

SECOND: That at said meeting the following resolutions amending the Articles of Incorporation of said corporation were offered:

"RESOLVED: That Article VII of the Articles of Incorporation of Silver Star-Queens Mines, Incorporated, be, and the same hereby is, amended to read as follows:

'Article VII. All of the authorized shares of this Corporation shall be of one class, to-wit: common stock. The shares of the Corporation shall not be subject to assessment.'

"RESOLVED FURTHER: That the President and Secretary of said Corporation be, and they hereby are, authorized and directed to make, execute, and swear to Articles of Amendment and to cause such articles of amendment to be filed with the Secretary of State of Idaho, and filed for record in the office of the County Recorder of the county in which the registered office of the said Corporation is located in the manner required by law."

THIRD: That the resolutions set forth above were adopted by the vote of holders in excess of two-thirds of the voting power of all shareholders.
