ARTICLES OF INCORPORATION

In compliance with the requirement of the law of Idaho relating to nonprofit corporations and acts amendatory and supplemental thereto, including particularly Title 30, Chapter 3, Idaho Code, the undersigned natural person, being of full age and a resident of the United States, in order to form a nonprofit corporation for the purposes hereinafter stated, does hereby as incorporator, adopt the following Articles of Incorporation and certify:

ARTICLE I

NAME

The name of the corporation is SOUTH FORK PAYETTE HOMES SUBDIVISION HOMEOWNER'S ASSOCIATION, INC., hereinafter called the "Corporation."

ARTICLE II

NONPROFIT CORPORATION

This Corporation is a nonprofit corporation without capital stock.

ARTICLE IV

PURPOSE AND POWERS OF THE CORPORATION

This Corporation shall be a nonprofit membership Corporation. The purpose of the Corporation shall be to provide for the maintenance, preservation, and control of Lots 1, 2, 3, 4, and 5 of the Southfork Payette Homes Subdivision located in Boise County, Idaho, and the maintenance, preservation, and control of the Common Area, including the road rights-of-way and easements in the Southfork Payette Homes Subdivision, for the benefit of the members herein, and for these purposes it shall possess such powers as are necessary and lawful.

ARTICLE V

MEMBERSHIP

Every person or entity who is a record owner of Lots 1, 2, 3, 4, or 5, Southfork Payette Homes Subdivision, Boise, County, Idaho, shall be a member of the Corporation. Rights-of-way and easements conveyed to the Corporation are declared the Common Areas of the Association herein. The foregoing is not intended to include persons or entities who hold an interest in a lot as security for the performance of an obligation. Membership shall be appurtenant to and shall not be separated from the ownership of any lot which is subject to assessment by the Corporation.

ARTICLE VI

VOTING RIGHTS

Each member of the Corporation shall only be entitled to one vote for the lot in which they hold that interest required for membership in accordance with the Bylaws of the Association.
